

AFFIDAVIT FOR ARREST WARRANT # 15CP043332

Before me, the undersigned authority, on this date personally appeared DETECTIVE JEREMIAH FILION, #216, hereinafter called the AFFIANT, who after being duly sworn upon HIS oath deposes and says he has good reason to believe and does believe that

did on July 30, 2015, against the peace and dignity of the State of Texas commit the offense,

Assault (a)(3)
Class C Misdemeanor

of the Texas Penal Code in Colleyville, Tarrant County, Texas. The AFFIANT is employed by the City of Colleyville Police Department and is currently assigned to the CRIMINAL INVESTIGATION SECTION. The AFFIANT has been a Law Enforcement Officer for over 13 years, with over 7 of those years in Criminal Investigations. The AFFIANT further states that HIS reason for believing the same is based upon the following facts:

On Friday, July 31, 2015 the Colleyville Police Department received a report of assault. The complainant, Ty Williams stated he was a real estate agent. On July 29, 2015 Williams met with Tommie Marvin Hawkins, Jr. (B/M 08/24/1968, TX DL: 11345815) as Hawkins expressed interest in purchasing a million dollar home in the Colleyville area. Williams showed Hawkins houses on the July 29th and 30th. Hawkins insisted on driving. When they returned to Williams' vehicle on July 30th, Hawkins told Williams he had been to the doctor and learned that he had a medical condition and Hawkins needed to "get his balls drained". Hawkins said his sexuality was suppressed and he needed Williams to "show him how to masturbate". Hawkins placed his hand on Williams' thigh, which Williams found to be offensive. Hawkins unbuckled his seatbelt and began moving in his seat. Williams exited the vehicle and left. Williams later learned that Hawkins was a registered sex offender. Williams identified Hawkins by his photo on the sex offender website.

The Affiant received calls from at least 4 other realtors who reported similar uncomfortable encounters with Hawkins as far back as October of 2013. None of the other realtors reported any physical contact; just bizarre behavior and sexual conversation that made them uneasy.

The Affiant later met with Williams and learned that Hawkins showed Williams convincing documentation demonstrating Hawkins' financial ability to purchase a million dollar home. Williams believed the documents were fabricated.

The Affiant confirmed that Hawkins is a registered sex offender whose original offense was indecency with a child (PC 21.11 (a)(1)). Hawkins was no longer on probation.


